



RECONSTITUTION OF TRUST DEED

THIS RECONSTITUTION OF TRUST DEED is made on this 26th day of May 2015 by the following Founders and Authors.

That on 04.05.2006 the Founders and Authors of Sri. Gurudeva Educational Trust has created Trust through the Registered Deed of Trust which is registered as document No. BLT-4-00013/2006-07, dated 04.05.2006 and also stored in C.D. No. BLTD11. The above Trust came to be registered before the jurisdictional Sub Registrar, Belthangady. As per that Trust Deed all the existing Trustees collectively constitute Board of Trustees.

That some of the trustees namely Sri.A.Krishnappa Poojary, Smt.Neelamma, Sri.Seetharam and Sri.Chitharanjan have given their resignation to the post of Trustee on 14.06.2006, 20.05.2008 and 05.01.2015 respectively. The said resignations were accepted by the Board of Trustees in its meetings dated 15.06.2006, 31.05.2008 and 14.03.2015. The Board of Trustees is desirous of taking some additional Trustees for the smooth functioning of the Trust. Hence on 16.07.2008 and 02.01.2013 there was a resolution passed in Board of Trustees Meeting and also takes decision by all the Trustees of the above Trust and decided to appoint new trustees as per the powers / authorities exercised by the Trustees as per the recitals mentioned in Clause 7 (b) of the above Trust Deed. Now all the existing trustees including additional trustees as appointed under the resolution of Board of Meeting are in the above Trust.

Whereas the Founders and Authors are linguistic minority community members whose mother tongue is Tulu and Telugu are desirous of creating a Trust to establish and administer Educational Institution such as General, Technical, Commercial, Medical, Industrial and all kinds of Education with the aims and objects stated here in below.
